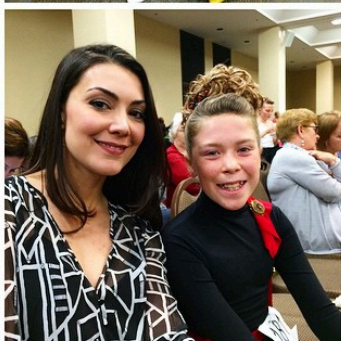
Golden State Feis, San Francisco a Success for McKeever Students!!
